

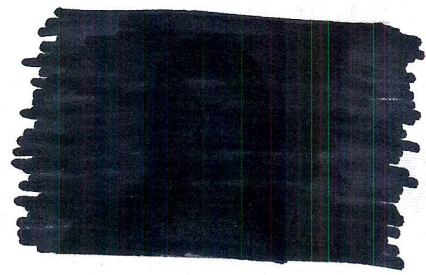

HOW TO SUBMIT YOUR LICENSE APPLICATION:

Now that you passed your license examination, the next step in the process is to submit your application. To do this you will use the California Department of Insurance's (CDI) on-line application service called FLASH. As soon as the day after you passed the examination, you may log-on to CDI's website at www.insurance.ca.gov and enter FLASH in the SEARCH box on the main page to retrieve the link to the FLASH online application. During the application process, the FLASH online application will confirm that you passed your license examination by verifying the California ID number* noted above.

Please note that after passing the license examination, (1) bail applicants are to complete and mail the Bail Application for Insurance License, form LIC 431-1 and (2) the independent or public insurance adjuster applicants are to complete and mail the Adjuster Application for Insurance License, form LIC 041-A. These applications are available on CDI's website at www.insurance.ca.gov. In the SEARCH box on the main page enter the appropriate license form number to retrieve and print the license application. The completed bail application and independent or public insurance adjuster application is to be mailed to the California Department of Insurance, P.O. Box 1139, Sacramento, CA 95812-1139.

The following items are required before CDI's Producer Licensing Bureau can complete the review of your license application:

First, fingerprint impressions are required for any unlicensed applicants. You may have submitted your fingerprint impressions at CDI examination sites, PSI test centers, or through a California Department of Justice authorized vendor. If you have not submitted fingerprints, please submit them immediately using CDI's Live Scan Request form LIC 442-39A.

*The California ID number consists of the last four digits of your social security number (e.g. ####) followed by your birth date (e.g. mmddyyyy). This information reflects the PSI registration information that you submitted to PSI to schedule the license examination. Please ensure that the last four digits of your SSN and your birthdate listed in the California ID are correct. If the information is incorrect, you will not be able to submit your license application. Please contact CDI at (800) 967-9331 for instructions on how to submit your license application.

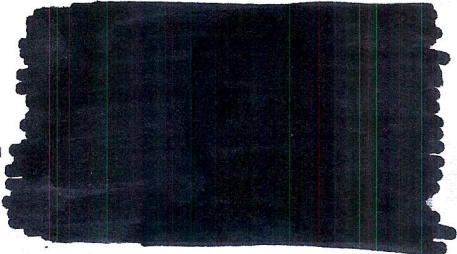

The following items are required before CDI's Producer Licensing Bureau can complete the review of your license application:
